Third-Party Fundraiser Guidelines

The reputation of the Lupus Foundation of America, Illinois Chapter is affected by how third-party fundraisers are conducted. Therefore, LFAI reserves the right to decline an offer for a third-party fundraiser or to discontinue association with a third-party fundraiser if it is considered to be in conflict with the Foundation's mission, violates any of the guidelines, or proves not to be in the best interest of the LFAI. The guidelines below are designed to eliminate confusion about the role of LFAI in third-party fundraising events.

1. A completed **Third-Party Fundraiser Form** must be approved by the Lupus Foundation of America, Illinois Chapter before any reference to the LFAI can be made in event materials.
2. LFAI is not obligated to provide staff or volunteer resources for third-party fundraisers. It is at the Foundation's discretion whether to do so.
3. Although LFAI will not distribute our mailing list to third parties, if provided with promotional materials, we will distribute them to our constituents. (Participation from our mailing list is not guaranteed)
4. LFAI must approve any printed materials bearing its name and/or logo prior to publication. All use of the LFAI name or logo must include a clear description of how the Foundation benefits from the event (Example: "A portion of the proceeds benefit the Lupus Foundation of America, Illinois Chapter")
5. LFAI will not be responsible for any expenses or fees (direct or reimbursable) on behalf of the third-party organizer.
6. If donations are not made directly to the LFAI, it is not the responsibility of the LFAI to send acknowledgement letters to the donor for tax purposes.
7. The LFAI is not responsible for securing any licenses, permits or insurance for third-party fundraisers. Nor will it assume liability for any fees, fines or legal action associated with the absence of necessary licenses, permits or insurance.
8. Third-party fundraisers cannot use the LFAI's name, logo or tax ID number to receive non-profit discounts on venues, services, products, entertainment, etc.
9. LFAI cannot be held legally responsible for any contracts signed by the third party or disputes arising from a third-party fundraiser. LFAI must be held harmless from any and all problems that arise.
